

Santander Universities £10,000 Prize Draw

Terms and Conditions

Overview

At Santander, we're committed to connecting as many students as possible with the tools they need to make the most of their studies. Santander Universities is providing 10 undergraduates and postgraduates – from all UK universities - the opportunity to receive a Santander Grant worth £1,000 to support their university studies. Successful applicants will be able to use the grant value as credit to buy a range of resources directly from the [Santander Aspire webstore](#) (owned and managed by JS Group). Or they can withdraw the Grant as cash to fund their university studies and needs.

Before entering the prize draw, please take the time to read through these Terms and Conditions and make sure you meet all the criteria listed below.

Terms and Conditions

These Terms and Conditions apply to the Santander Universities £10,000 Prize Draw (collectively referred to as the "Grant"). By applying to the prize draw, applicants agree to be bound by the following Terms and Conditions:

1. The Grantor is Santander Universities UK (a division of Santander UK plc, 2 Triton Square, Regent's Place, London, NW1 3AN, United Kingdom).
2. To enter, you'll need to meet the following eligibility criteria:
 - a. you must currently be studying an undergraduate or postgraduate degree (during the 2023/2024 academic year) at any UK university. You can also enter if you're doing a degree apprenticeship
 - b. you must be a UK resident
 - c. you must be able to provide a valid university student ID number
 - d. you must confirm which UK university you attend.
3. You can enter the prize draw via Santander Open Academy any time from 09:00 (GMT) on 11 March 2024 until 23:00 (GMT) on 25 April 2024. Santander Universities reserves the right to close the prize draw early in exceptional circumstances (acting in its discretion).
4. Entries not submitted in accordance with these Terms and Conditions, or entries which are delayed, duplicated, incomplete, illegible, mislaid or lost through technical problems will be disqualified. No responsibility is accepted for such entries. Proof of submission online won't be accepted as proof of submission.
5. You can only enter the prize draw once.
6. It's your responsibility to ensure you read and understand the eligibility criteria and submit your entry appropriately, on time and following the entry instructions or requirements as indicated on Santander Open Academy.
7. Santander Universities will select 10 winners at random using an online random selection platform. If you want to find out more about this process, please contact santander.universities@santander.co.uk.
8. Once the 10 winners have been identified, Santander Universities will verify their student status.
 - a. As part of this verification process, Santander Universities will share the winners' names, email addresses and student ID numbers with their respective universities. This will take place before the results are announced and will only apply if the winners attend a partner university (you can see a list of our partners [here](#)).
 - b. If any of the winners attend a non-partner university, Santander Universities will confirm the verification process directly with the winners before the results are announced. The respective winners must then verify their eligibility by meeting the requirements outlined. Santander Universities will make 2 attempts to contact each of the winners by email, with a gap of at least 24 hours between each email, and a phone call if a valid phone number is provided. If after this, Santander Universities decides

that it's not possible to get in touch with any of the winners, a new winner will be selected at random among the remaining applicants following the original process.

- c. If the selected winners or respective partner universities are unable to verify the student status, a new winner will be selected at random to receive the Grant instead.
9. If successful, you'll receive an email directly from the Santander Open Academy Platform which confirms that you've been selected as a winner. On receiving this, you must accept the Grant before 27 May 2024. You can do this by clicking on the link in the email. You could also accept directly by logging on to Santander Open Academy and viewing 'My Applications'. If, after 2 email attempts with a gap of at least 24 hours between them and a phone call (if a valid phone number is provided), Santander Universities decides that it's not possible to get in touch with you to confirm acceptance of the Grant, a new winner will be selected among the remaining applicants following the original process.
10. If successful, and once you've accepted the Grant, Santander Universities will share your details with JS Group (the third party managing the Santander Aspire webstore) within 7 days after the Grant acceptance window closing on 27 May 2024. JS Group will create your account on the [Santander Aspire webstore](#) so that you can access your grant value. Successful applicants will receive 2 emails from JS Group: one that will include a link to the Santander Aspire webstore, including their log on details, and another that will confirm the grant value. We encourage you to review JS Group's privacy notice to understand how they'll store and process your personal data when you use the webstore.
11. Once the successful applicants have logged on, they'll be able to browse the [Santander Aspire webstore](#) where they'll be able to purchase a variety of products or services using the grant value they've been awarded. Alternatively, they'll be able to withdraw the Grant as cash into their bank accounts; JS Group will provide a step-by-step guide on how to do this once the individuals log on to their webstore account. The value of the Grant will automatically be credited to their JS Group user accounts.
12. The credit which is applied to the successful applicants' accounts will be valid for 12 months. This will start from the date when you receive your log on details from JS Group. The credit applied to your account will be removed after the 12 month period.
13. The winners' surnames and counties will be available on request after 20 May 2024 for 30 days. Please contact santander.universities@santander.co.uk to get these. The winners' information and winning entries (if applicable) must be provided to the Advertising Standards Authority on request, in the event of a dispute.
14. If successful, you might be invited by Santander Universities or by your university (if you attend one of our partner universities) to provide a testimonial or case study. Please note, we won't publish a testimonial or case study without your permission.
15. Please be aware that, if you're identified as a winner and you attend a partner university, the Grantor will inform your university of your success.
16. Please be aware that if requested by a partner university, and if you've provided consent, Santander Universities will inform your university of your entry into the prize draw.

General terms

1. Santander Universities reserves the right to withdraw any entry to the prize draw that is found to be in breach of any of the pre-established conditions and/or rules laid out in the Term and Conditions.
2. Santander Universities reserves the right to update or amend these Terms and Conditions or foreclose the prize draw without prior notice at any time.
3. Santander Universities reserves the right in its sole discretion to disqualify any individual that corrupts or affects the administration, security, fairness, integrity, or proper conduct of this prize draw.
4. The prize draw and these Terms and Conditions are governed by English law and any disputes will be subject to the exclusive jurisdiction of the courts of England.

5. To the fullest extent permitted by law and excluding death or permanent injury caused as a result of Santander Universities' negligence, Santander Universities accepts no liability for loss or injury as a result of the prize draw or receipt or misuse of any prize fund.
6. No cash or other alternatives to the Grant will be offered. Santander Universities accepts no responsibility for entries lost, damaged or delayed in transit.
