

Santander UK – Fuel Your Studies Prize Draw

Terms & Conditions

Overview

At Santander, we're committed to helping students thrive by providing the support and resources they need to succeed in their studies. We understand that the rising cost of living can make student life especially challenging - particularly for those living away from home. That's why we're giving away £500 in food and supermarket vouchers to 150 students from Further Education (FE) and Higher Education (HE) institutions across the UK, with winners selected throughout the campaign period. There will be 25 winners in August, 25 winners in September, and 100 winners in November. These vouchers can be redeemed at three major UK supermarkets - Tesco, Sainsbury's, and Aldi - as well as popular food outlets including Just Eat, Nando's, Zizzi, Greggs, Costa Coffee, and Caffè Nero amongst others. Winners will be able to claim their prize directly through the [Santander Aspire webstore](#), which is owned and managed by JS Group.

Before entering the prize draw, please read through the following terms and conditions and make sure you meet all the criteria listed below.

Terms & Conditions

These terms and conditions apply to the Santander Universities – Fuel Your Studies Prize Draw collectively referred to as the “prize draw”. By applying to the prize draw, you agree to be bound by the following terms and conditions:

1. The Provider is Santander UK plc, 2 Triton Square, Regent's Place, London, NW1 3AN, United Kingdom.
2. To enter, you'll need to meet the following eligibility criteria:
 - You must be aged 18 or older and resident in the UK.
 - Applicants must be already studying at any Further Education (FE) or Higher Education (HE) institution or about to commence studying (starting in September or October of the 2025/2026 academic year). This includes any undergraduate or postgraduate degree at any UK university at the time of applying (this does not include students who have graduated at the end of the 2024/2025 academic year and who aren't commencing postgraduate studies in the 2025/2026 academic year).
 - You can also enter if you're doing a degree apprenticeship.
 - You must be able to provide a valid student ID number.
 - You must confirm which UK institution you attend.
 - You must register on the Santander Open Academy platform (if not already a user).
3. **To enter:** You can enter the prize draw via the Santander Open Academy platform any time from 09:00 (GMT) on 28/07/2025 until 23:59 (GMT) on 13/11/2025 with consecutive prize draw entry periods detailed below in Table 1.

You'll be asked to accept your prize on the Santander Open Academy platform following the prize draw closing on 14/11/2025. This doesn't impact you receiving your prize.</p>
3	<p>Entry period: Apply between 09:00 GMT on 01/10/2025 and 23:59 GMT on 13/11/2025. Your entry will be included in prize draw period 3 automatically.</p> <p>Selection: 100 winners will be randomly selected on 14/11/2025 from the entries received from 28/07/2025 to 13/11/2025.</p> <p>Acceptance: If selected as a winner, you must accept your prize through the Santander Open Academy platform by 17:00 (GMT) on 21/11/2025.</p>

4. You can only enter the prize draw once. Your single application will provide you an entry into each of the 3 prize draws providing if you have applied by the draw entry period outlined.
 - Draw 1 - Apply between 09:00 (GMT) on 28/07/2025 and 23:59 (GMT) on 31/08/2025 - entry to all 3 draws (Prize draw period 1, 2 and 3)
 - Draw 2 - Apply between 09:00 (GMT) on 01/09/2025 and 23:59 (GMT) on 30/09/2025 - entry to 2 draws (Prize draw period 2 and 3)
 - Draw 3 - Apply between 09:00 (GMT) on 01/10/2025 and 23:59 (GMT) on 13/11/2025 - entry to 1 draw (Prize draw period 3).
 5. Entries that do not meet these terms and conditions, or entries which are delayed, duplicated, incomplete, illegible, mislaid or lost through technical problems will be disqualified. No responsibility is accepted for such entries. Proof of submission online will not be accepted as proof of submission.
 6. It is your responsibility to ensure you read and understand the eligibility criteria and submit your entry appropriately, on time and following the entry instructions/requirements indicated on Santander Open Academy.

 8. **Prize acceptance:** If successful, you'll receive an email directly from Santander Universities santander.universities@santander.co.uk confirming that you have been selected as a winner as outlined in Table 1 confirming selection and acceptance dates per prize draw period.
 - Draw 1 – You must accept the prize by replying to the email to by 17:00 (GMT) on 08/09/2025.
 - Draw 2 – You must accept the prize by replying to the email to by 17:00 (GMT) on 08/10/2025.
 - Draw 3 - You must accept the prize on the Santander Open Academy by 17:00 (GMT) on 21/11/2025.
- If, after 2 email attempts (with 24+ hours separation) and a phone call (if a number is provided), Santander cannot contact you, a new winner will be randomly selected from the entries received.
9. Once the prize draw has closed, all winners will be asked to accept the prize on the Santander Open Academy platform. You will receive an email from the platform from 23:00 (GMT) on the 14/11/2025 to invite you to accept your prize. Draw 3 winners must accept by 17:00 (GMT) on 21/11/2025 to receive your prize. You can accept by clicking the link in the email or logging into Santander Open Academy and viewing 'My Learning'. Draw 1 and 2 winners are encouraged to accept but non-acceptance on the Santander Open Academy platform will not impact you receiving your prize as you'll have already received it.
 10. If successful, and once you've accepted the prize by email for the entry period you have been selected, Santander will share your details (including first name, last name, email address and institution you attend) with JS Group, the third party managing the Santander Aspire webstore, within 7 days after the acceptance window closes for your prize draw entry period.
JS Group will create your account on the Santander Aspire webstore so that you can access your prize. Successful applicants will receive 2 emails from JS Group: one which will include a link to the Santander Aspire webstore, including log-in details, and another which will confirm your prize and how you can redeem your food vouchers. We
