

Fairer Futures Prize Draw Terms & Conditions

Overview

Milton Keynes College have partnered with Santander to offer 15 students a chance to win some incredible prizes to connect them with the resources they need to make the most of their studies.

You could win a brand-new Apple MacBook Air M2 (worth £999), an Apple iPad 10th Gen (worth £349, 2 available), or one of 12 awards of £100 to purchase a variety of resources in the Santander Aspire webstore (owned and managed by JS Group). The webstore offers a range of resources including mobile phone top ups, grocery vouchers, headphones, stationary, sport and fitness and much more.

Before entering the prize draw, please read through the following Terms and Conditions to ensure you meet all the criteria listed below.

Terms and Conditions

These Terms and Conditions apply to the Fairer Futures Prize Draw (collectively referred to as the “grant”). By applying to the prize draw, you agree to be bound by the following Terms and Conditions:

1. The Grantor is Milton Keynes College
2. To enter, you’ll need to meet the following eligibility criteria:
 - a. You must be aged 16 or older and resident in the UK.
 - b. You must currently be registered and studying at Milton Keynes College during the 2024/2025 academic year.
 - c. You must be able to provide a valid student ID number.
3. You can enter the prize draw via the Santander Open Academy platform any time from 09:00 (GMT) on 22/04/2025 until 23:00 (GMT) on 06/06/2025. Milton Keynes College and/or Santander reserves the right to close the prize draw early in exceptional circumstances (acting at its discretion).
4. Entries that doesn’t meet these Terms and Conditions, or entries which are delayed, duplicated, incomplete, illegible, mislaid or lost through technical problems will be

disqualified. No responsibility is accepted for such entries. Proof of submission online will not be accepted as proof of submission.

5. You can only enter the prize draw once.

6. It is your responsibility to ensure you read and understand the eligibility criteria and submit your entry appropriately, on time and following the entry instructions/requirements indicated on Santander Open Academy.

7. Milton Keynes College will select 15 winners at random using an online random-selection platform. If you want to find out more about this process, please contact Vivian Lam at vivian.lam@mkcollege.ac.uk

8. If successful, you'll receive an email directly from the Santander Open Academy platform on 16/06/2025 which confirms that you've been selected as a winner. Upon receiving this, you must accept the grant before 17:00 (GMT) on 23/06/2025. You can do this by clicking on the link in the email. You can also accept directly by logging into the Santander Open Academy platform and viewing 'My Learning'.

If you do not confirm acceptance of the grant by the deadline and it has not been possible to contact you after 2 email attempts with at least 24 hours separation between them and a phone call (if a valid phone number is provided), a new winner will be selected among the remaining applicants following the original process.

9. If successful, and once you've accepted the grant, Milton Keynes College will share personal information with the JS Group, the third party managing the Santander Aspire webstore, by 26/06/2025. This personal information may include first name, surname, email address, college name and prize awarded.

JS Group will create your account on the Santander Aspire webstore so that you can access your prize awarded (either a £100 grant, MacBook Air or Apple iPad (depending on what you have been awarded)). Successful applicants will receive 2 emails from JS Group: one which will include a link to the Santander Aspire webstore, including log-in details, and another which will confirm the grant value. We encourage you to review JS Group's privacy notice to understand how they'll store and process your personal data when you use the webstore.

10. If you are a winner of a £100 prize, you will be able to browse the Santander Aspire webstore where you'll be able to buy a variety of products/services using the £100 grant as part or full payment. The value of the grant will automatically be credited to your JS Group user account. The credit which is applied to successful applicants' accounts will be valid for 12 months. This will start from the date when you receive your log-in details from JS Group. The credit applied to your account will be removed after the 12-month period.

11. If you are a winner of a MacBook Air, you'll be able to request an Apple MacBook Air 13-inch: Apple M2 chip with 8-core CPU and 8-core GPU, 256GB SSD, 16GB unified memory in Space Grey, worth £999. You'll have 12 months to collect your MacBook Air, starting from

the date when you receive your log-in details from JS Group. Your account will be credited with £999, and this can only be used to order the MacBook Air specified.

12. If you are a winner of an Apple iPad, you'll be able to request an Apple iPad 10.9-inch (10th Gen) 64GB in Silver, Blue or Pink, worth £349. You'll have 12 months to collect your Apple iPad starting from the date when you receive your log-in details from JS Group. Your account will be credited with £349, and this can only be used to order the Apple iPad specified.

13. Milton Keynes College reserve the right to verify the student status of any winners in the prize draw. This may include requesting proof of enrolment or any other relevant documentation. Failure to provide sufficient proof of student status upon request will result in disqualification from the prize draw.

14. If successful and you are found not to be a student after verification, you will be asked to return any prizes awarded. Additionally, any costs incurred by the company because of this non-compliance may also be recovered.

15. This prize draw is being jointly run by Santander UK PLC and Milton Keynes College. The Santander Open Academy platform is not being run or administered by the college.
