Pricing

Non Delivery or Shortage

If your item was sent using standard delivery (Royal Mail untracked): Please allow 7 days for your item to arrive from the day we sent you a despatch email. At peak times like Christmas & Black Friday, due to the high volume of parcels at these times of the year, deliveries may take longer than the usual to arrive - at these times allow 14 days for untracked Royal Mail deliveries.

Please note we need to be notified in writing within 30 days of despatch if your item has not arrived with you. IMPORTANT: If your item was sent using a courier service (tracked and signed): Please notify us of non-delivery within 48 hours from the date of despatch. This is the time-frame we are given by our couriers to raise an investigation.

High value orders will need a signature when they are delivered to a home or work address. Many of our couriers will make several attempts to deliver a package.
