THE REGULATIONS AND THE CALL FOR THE "UNIVERSITAT DE GIRONA / BANCO DE SANTANDER" GRANTS FOR THE MASTER'S DEGREE STUDIES AT THE UNIVERSITY OF GIRONA FOR THE 2022-23 ACADEMIC YEAR. FORMAT FOR INTERNATIONAL STUDENTS

1.- Aim of the call

One of the priorities of the quality policies of university studies is its internationalization. With regard to official master's degrees, this translates into the need for talented international students, the incorporation of prestigious international professors and the establishment of partnerships with foreign universities to offer double international degrees. These three aspects are independent, but there is an important inter- relationship that reinforces them mutually.

For this reason, the University of Girona has developed a programme of tuition grants for students from outside the Spanish university system who want to take an official master's degree at the UdG. These grants are intended to help promote the internationalization of the master's degrees of the University of Girona.

The aim of this call is to award tuition fees grants for the official master's degrees of the University of Girona listed in Annex I to students who have obtained a degree that gives access to the master's degree from a university that does not belong to the Spanish university system.

2.- Proposed budget and value of grants

The total amount allocated to this call is €86.000 from the costing unit 11.12.014.0006 and budgeting application 481.99. The maximum amount of each grant will be the total of the enrolment costs for 60 credits, to a maximum of €3952.20, of an official master's degree from the University of Girona for the academic year 2022-2023. The Government of Catalonia in the decree that fixes the prices of academic services in public universities in Catalonia for the 2021-2022 academic year will determine this amount.

3.- Grant recipients

Students that have been pre-enrolled in the master's degree courses listed in Annex I may apply for these grants. Although grants can be applied for in all the masters in which they are pre-enrolled, only one grant per person will be awarded and provided that the applicant is not in possession of, or fulfils the legal requirements for obtaining, a degree of the same level or higher.

4.- Requisites of the candidates

Those interested in being beneficiaries of the grants must meet the following requirements, at the deadline for submission of the applications:





- a. Have completed the studies that give access to the master's degree in a university outside Spain.
- b. Do not have a Spanish residence permit.
- c. Do not be in possession of, or fulfil the legal requirements for obtaining, a previous master's degree issued by a Spanish university, or a degree of higher level.
- d. Have pre-enrolled for any of the official master's degrees listed in Annex I.
- e. Have paid the corresponding administrative fee for a university master's degree, in accordance with the decree of current prices for the academic services of the Catalan public universities.
- f. The pre-enrolment to the Master's Degree must be completed along with all the required documentation, including the GPA Equivalence Document from the Ministry of Education.
- g. If applying for a master's degree with professional attributions, the applicant must meet the requirements established by Royal decree 967/2015, of November 21st, which regulates the requirements and the procedure for the official recognition and validation of foreign university degrees in Spain.

In case of exceptional cases that are not in accordance with these requirements, specifically with the b) one, the Assessment Committee is empowered to analyse the case and determine whether the application must be admitted or not.

5.- Submission of applications

Applications must be submitted online through the Bank of Santander platform (https://www.becas-santander-com/es). The platform requires the applicant's registration.

The interested party will receive confirmation of the presentation of your application by email. Without this confirmation email, the application will not be considered as submitted.

6.- Deadline for submission of applications and procedure

The deadline for submission of applications will begin on the day after the announcement of the call on the electronic noticeboard of the University of Girona webpage and will end on May 27th at 11:59 p.m. (Girona local time)

Within a maximum period of 10 working days following the end of the period for submission of applications, the provisional list of admissions and exclusions will be published on the electronic noticeboard of the University of Girona webpage, indicating the reason for any exclusion. There will be a period of 10 working days to present the required documentation or formulate any allegations that are considered relevant. Failure to present these within the 10 days will lead to the application being withdrawn, in accordance with article 68 of the Law 39/2015, of 1 October, on common administrative procedure of public administrations. The submission of the application implies the acceptance of the regulations of this call.

7.- Authorization to obtain data

The presentation of the grant application involves authorizing the University of Girona to obtain and contrast the necessary data of the applicant and the members of the family unit that are liable for tax with the public authorities, universities or of higher education study centres, that correspond in each case. This includes the Spanish State Tax Administration





(AEAT), the land registry or any other administration, with the aim of satisfactorily undertaking the procedure. Should there be any technical difficulties that impede the transfer of data, the necessary documents may be requested from the applicant.

8.- Assessment, selection and awarding of the grants

a. The selection body for applications will be an Assessment Committee, which will propose a resolution, to be raised to the rector within a maximum period of 5 working days. The Committee will be assisted by the Grants and Scholarships Section, which will advise on the submitted applications.

The Assessment Committee will be composed:

President: The Vice-Rector for Teaching and Academic Planning, or a person

delegated by the same.

Members: The Vice-Rector for Students, Mobility and Employment, or a person

delegated by the same.

A representative chosen from the deans who are part of the Delegate

Commission for Teaching and Students.

A representative chosen from the directors of departments and institutes that are part of the Delegate Commission for Teaching and

Students.

A representative from the students that are part of the Delegate

Commission of Teaching and Students.

Secretary: The head of the Academic and Student Management Service or

delegated person, with voice and no vote.

b. The evaluation, selection and awarding of the grants will be made in accordance with the following criteria:

- The applications will be ordered according to the GPA equivalence document of the academic transcript.

- An assignment of one grant to each master's programme will be made to the applicants with the highest GPA, until the available amount of this call is exhausted.
- In case that there were any remaining amount, a second assignment will be made, with a limit of a second grant, to each master's degree.
- In case that there were any remaining amount, the grants will be assigned on a GPA equivalence basis, regardless of the master's degree chosen by the applicant.

Applicants who are not awarded a grant will be placed on a waiting list.





In the case of resignations, revocations or non-enrolment of the beneficiaries, the grant will be awarded according to the published waiting list, and the available grant will be assigned to the first applicant for the same master's programme as long as there are two or less beneficiaries for that programme. In case that there are already two beneficiaries for the same programme, the available grant will be assigned according to the waiting list.

In the case that there are no more applicants on the waiting list for the same master's programme, the available grant will be assigned to the first person off the waiting list, regardless of the master's programme.

Considering the academic performance, these allocations may only be made until September 30th 2022, or until October 31th 2022 in case that the grant is assigned to students already enrolled in the corresponding master's degree.

In the event that the master's degree for which a student has obtained a grant is deprogrammed, the beneficiary or beneficiary may retain the grant if the student is awarded a place on another master's degree included in the list of Annex I for the academic year 2022-2023.

In the event of a tie, priority will be given to the candidates for the masters for which less grants have been awarded in the same call. In the event of a tie between applicants for the same master's programme, the grant will be awarded to the student with more courses with a grade of 9 or higher according to the GPA Equivalence Document issued by the Spanish Ministry of Education.

The Assessment Committee is empowered to decide and resolve all those issues that are not set out in the regulations of this call.

9.- Resolution

The rector of the University of Girona will resolve this call within a maximum period of 4 months from the end date of the presentation of applications. The resolution will be published on the electronic noticeboard of the University of Girona webpage.

10.- Notification, publication and protection of data

In accordance with article 45.1 of Law 39/2015, of 1 October, of the common administrative procedure of public administrations, all acts that are made in this call will be notified to the interested parties through publication on the electronic noticeboard of the University of Girona webpage. However, for purely informative purposes, the Grants and Scholarships Section may communicate the resolution to the interested parties by email, as well as any other act that it considers appropriate.

In accordance with article 6 of the General Data Protection Regulation 2016/679, of the European Parliament and of the Council, of 27 April 2016, the data will be processed by the University and will not be communicated or ceded without prior consent, except in the cases provided for by law.

The University understands that the applicant authorizes the processing of their data for this purpose. At any time, the applicant may exercise their rights of access, rectification, opposition





and cancellation by addressing the General Secretary of the University of Girona, Plaça Sant Domènec 3, 17004 GIRONA.

11.- Challenges/Objections

No appeal shall be filed against the legal proceedings that may arise, in accordance with article of Law 39/2015, of 1 October, on the common administrative procedure of public administrations. An appeal may be placed before the rector against the resolution of the awarding of a grant within a period of one month from the day following its publication, in accordance with articles 123 and 124 of the Law 39/2015, dated 1 October,

on the common administrative procedure of the public administrations, or directly file a contentious administrative appeal before the administrative litigation courts of Girona, within two months from the day following its publication, in accordance with articles 8.3, 14.1 and 46.1 of Law 29/1998, of 13 July, regulating the contentious administrative jurisdiction.

12.- Obligations of the beneficiary of the grant

In addition to the obligations set out in Law 38/2003, of 17 November, on general subsidies, and RD 1721/2007, which establishes the regime of personal grants and scholarships, the beneficiaries of these grants must fulfil the following obligations:

- a. Enrol in the first enrolment period established in the academic and administrative calendar for undergraduate, master's and doctoral studies for the 2020-21 academic year, between July 22nd 2022 and September 20th 2022.
- b. Enrol for 60 credits in an official master's degree course of the UdG, of those listed in annex I, for the 2022-2023 academic year. For these purposes, the credits recognized in the double degree agreements are included.
- Present the legalized documents (degree diploma and academic transcript) at the time of enrolment.
- d. Communicate resignation, if applicable, by means of a letter addressed to the Grants and Scholarships Section.

Resignation will produce the same effects as revocation.

13.- Incompatibilities of the grant

This grant is incompatible with any other grant for the same purpose.

In the case of incompatibility with the official grant offered by the Spanish Ministry of Education, the Grants and Scholarships Section will get in touch with the grantee so that they decide what grant

14.- Acceptance of the grant

Acceptance of the grant implies compliance with the obligations established in rule 12 of this call. The day after the publication of the resolution by the rector, the period of acceptance of the grant will open for a period of 10 working days.





The interested party will receive the acceptance document that must be returned duly completed and signed to the Grants and Scholarships Section. Likewise, the grantee must accept the grant through the notification received from the Bank of Santander via its website.

In the case any candidate proposed to receive the grant does not accept it, does not formalize the registration in the established period or the grant is revoked, the vacant grant will be awarded to the corresponding candidate following the order of the priority waiting list stated in the call, provided that this vacancy occurs within the period established in rule 8 of this call.

The substitute candidates will have a period 10 working days to accept the grant from the date of notification by the Grants and Scholarships Section.

15.- Non-compliance and revocation of the grant

The total or partial non-fulfilment of the obligations and requirements established in the regulations of this call, or of the conditions contained in the resolution of the award, or by concealment or falsification of data, will give rise to the loss of the right to payment of the grant and the obligation to repay the amounts received, with the previous processing of the corresponding record.

Failure to enrol in the master's degree for which the grant was awarded will result in the revocation and will not require explicit renunciation.

Leaving the studies or not passing more than 50% of the enrolled credits will be cause for revocation of the grant.

In the event of revocation, the University of Girona will require the affected person to pay the corresponding tuition fees or the repayment of the grant, as appropriate, with notice that the non-payment of the corresponding amounts will be considered a debt in the terms established by the current decree fixing the prices of academic services in the public universities of Catalonia
