# Santander Universities Research Grants

## **Terms & Conditions**

### **Overview**

Santander Universities are providing the opportunity to win one of 50 research grants worth £1,000 each, to staff at UK universities conducting any form of research and postgraduate students at any UK university. Successful applicants will be able to either withdraw the funds from the Santander Aspire webstore (owned and managed by a third party, JS Group) or purchase products directly from the Santander Aspire webstore.

Before entering the prize draw, read through these terms and conditions to make sure you meet all the criteria listed.

# **Terms & Conditions**

These terms and conditions apply to the Santander Universities Research Grant Prize Draw (referred to as the "prize draw"). By applying to the prize draw, applicants agree to be bound by the following:

- 1. The Grantor is Santander Universities UK (a division of Santander UK plc, 2 Triton Square, Regent's Place, London, NW1 3AN, United Kingdom).

  - a. You must currently be studying a postgraduate degree (during 2023/2024 academic year) or be a member of staff at any UK university conducting any form of research.
  - b. You must be a UK resident.
  - c. You must be able to provide a valid university ID number or valid University Staff ID number.
  - d. You must confirm which UK university you attend.
- You can apply via the Santander Scholarship Platform any time from 09:00 (GMT) on 17/07/2023 until 23:00 (GMT) on 12/10/2023. Santander Universities reserves the right to close the prize draw early in exceptional circumstances (acting in its discretion).
- 4. Entries not submitted in accordance with these terms and conditions, or which are delayed, duplicated, incomplete, illegible, mislaid or lost through technical problems will be disqualified. No responsibility is accepted for such entries. Proof of submission online will not be accepted as proof of submission.
- 5. You can only enter the prize draw once.
- 6. It's your responsibility to ensure you read and understand the eligibility criteria and submit your entry appropriately, on time and following the entry requirements as shown on the Santander Scholarship Platform.
- 7. Santander Universities will select 50 winners at random using an online random-selection platform. If you want to find out more about this process, please contact santander.universities@santander.co.uk.
- 8. Once the 50 winners have been identified, Santander Universities will verify their status.
  - a. As part of this verification process, Santander Universities will share the winners' names, email addresses and ID numbers with their respective universities. This will take place prior to the results being announced.
  - b. If the winners attend a non-partner university, Santander Universities will confirm the verification process directly with the winner(s) ahead of the results being announced. The respective winner(s) must then verify their eligibility by meeting the requirements outlined. Santander Universities will make 2 attempts to contact the winner(s) by email, with at least 24 hours separation between them, and a phone call if a valid phone number is provided. If after this, Santander Universities

decides that it's not possible to get in touch with the winner(s), a new winner will be selected at random among the remaining applicants following the original process.

- c. Santander Universities will make 2 attempts to contact the winner(s) by email, with at least 24 hours separation between them, and a phone call if a valid phone number is provided. If after this, Santander Universities decides that it's not possible to get in touch with the winner(s), a new winner will be selected at random among the remaining applicants following the original process.
- d. Should the selected winners or respective partner universities not be able to verify the student status, a new winner will be selected at random to receive the research grant instead.
- 9. If successful, you'll receive an email directly from the Santander Scholarship Platform which confirms you've been selected as a winner. When you receive this, you must accept the research grant within 7 days of 06/11/2023. You can do this by clicking on the link in the email. Santander Universities may decide that it's not possible to get in touch with you if we email you twice with 24 hours in between and call you on a valid phone number without a response, to confirm you accept the research grant. If this happens, a new winner will be chosen from the remaining applicants following the original process.
- 10. If successful, and once you've accepted the research grant, Santander Universities will share your details with JS Group (the third party managing the Santander Aspire webstore). JS Group will create your account on the Santander Aspire webstore so that you can either withdraw your money or spend it on the Santander Aspire webstore. We encourage you to review JS Group's privacy notice to understand how they'll store and process your personal data when you use the webstore.
- 11. If successful, you'll have 12 months to withdraw/spend the £1000 research grant. This will start from the date when you receive your log-in details from JS Group. The credit applied to your account will be removed after the 12-month period.
- 12. The winners' surname and county will be available on request after 06/11/2023 for 30 days. Please contact santander.universities@santander.co.uk to get these. The winners' information and winning entries (if applicable) must be provided to the Advertising Standards Authority on request in the event of a dispute.
- 13. If successful, you may be invited by Santander Universities or by your university (if you attend one of our partner universities https://www.santander.co.uk/universities/our-partners) to provide a testimonial or case study. Please note, we will not publish a testimonial or case study without your permission.
- 14. Please be aware that, if you're identified as a winner, the Grantor will let your university know that you've won.
