## Eligibility

Santander will provide funding of £1,000 per student to enable students to undertake International Mobility. These can include internships, work and placement experiences.

To be eligible for the funding you must be in receipt of the Student Support Package and have received notification that the 2023/2024 overseas placement has been approved by the University. Approvals must be completed by 24<sup>th</sup> August 2023. Funding will be allocated on a first come first served basis.

The University shall administer this funding through the Santander Scholarships Platform – www.becas-santander.com.

To apply all required details on the Santander Scholarships Platform must be completed. You will be asked to submit a short statement briefly explaining the benefits of the placement to your future career planning and employability, and how the funding will help support you with associated costs not covered by the placement provider.

Successful candidates will be required to sign a Scholarship Agreement and payment will be made by bank transfer within 2 weeks of the start date of the placement.

Successful students will be asked to provide a short report on their return that reflects on their learning gains and employability skills; this will be shared with Santander Universities UK.

## Terms and conditions

If you are successful in your application, you should be aware of the terms and conditions set out below.

The University may withdraw your funding offer, or the award in the following circumstances:

- you are subsequently found to be ineligible for the funding or if these terms and conditions are not met in full.
- You fail to undertake or complete your placement personal circumstances may be reviewed by a panel.
- you suspend your programme, withdraw from your course or your position is withdrawn by us.
- you fail to meet the eligibility criteria set out in these terms and conditions.

In the event your award is withdrawn in accordance with the paragraph set out above, your funding will be cancelled, and you will be required to repay the award in full.

The University reserves the right to amend its scholarship and award provision without notice.

## **Engagement**

To help us convey the impact of supporting students like you and to thank existing donors, successful applicants will be asked to provide regular updates on their progress of their employability activity and degree programme, when requested, and a short report.

The successful applicant will be prompted to complete these reports by the University and given reasonable notice.

Your first name and course title, along with any reports or updates you submit, will be shared with the donor who has made your scholarship possible.

While a student at the University, the successful applicant will also be asked to attend, participate, and contribute to a range of activities and events that help to market and promote the impact of fundraising here at the University.

The University will also ask the successful applicant at times to participate in activities and events where donors or prospective donors will be present, and the successful applicant's name may be publicised.

A condition of you receiving the funding is that you meet the eligibility criteria listed. You agree to return the full award to the University if the information you have provided with respect of your eligibility is found to be inaccurate.

In addition, the University may, at its sole discretion, request the funding be returned if you withdraw or are suspended from your course.
