Terms & Conditions

2. MacBook Air is a trademark of Apple Inc. This promotion is not conducted in association with or endorsed by Apple Inc.
3. To enter, you’ll need to meet the following eligibility criteria:
 - a. You must be employed by Santander UK and have an E-number
 - b. You must be a resident in the United Kingdom, the Channel Islands, or the Isle of Man
 - c. You must apply using your official Santander UK email address
4. Anyone professionally connected with this prize draw is not eligible.
5. You can enter the prize draw via the [Santander Open Academy](#) platform any time from 09:00 (GMT) on 03/06/2024 until 23:00 (GMT) on 18/07/2024. Santander Education and Social Impact team reserves the right to close the prize draw early in exceptional circumstances (acting in its discretion).
6. Entries not submitted in accordance with these Terms and Conditions, or entries which are delayed, duplicated, incomplete, illegible, mislaid or lost through technical problems will be disqualified. No responsibility is accepted for such entries. Proof of submission online will not be accepted as proof of submission.
7. You can only enter the prize draw once.
8. It is your responsibility to ensure you read and understand the eligibility criteria and submit your entry appropriately, on time and following the entry instructions/requirements as indicated on the Santander Open Academy.
9. Santander Education and Social Impact team will select 10 winners at random using an online random-selection platform to receive the MacBook Air. If you want to find out more about this process, please contact santander.universities@santander.co.uk.
10. Once the 10 winners have been identified, Santander Education and Social Impact team will verify their employment status.
 - a. In case Santander Education and Social Impact team are unable to verify that you are employed by Santander UK, a new winner will be selected at random to receive the fund instead.
11. If successful, you’ll receive an email directly from the [Santander Open Academy](#) platform after 23:00 (GMT) on 25/07/2024 which confirms that you’ve been selected as a winner. Upon receiving this, you must accept the MacBook Air before 01/08/2024. You can do this by clicking on the link in the email. You could also accept directly by logging into Santander Open Academy and viewing ‘My Applications’.
12. If, after 2 email attempts with at least 24 hours separation between them and a phone call (if a valid phone number is provided), Santander Education and Social Impact team decides that it is not possible to get in touch with you to confirm acceptance of the prize, a new winner will be selected among the remaining applicants following the original process.
13. If successful, and once you’ve accepted the prize, Santander Education and Social Impact team will share your details with JS Group (the third party managing the Santander Aspire webstore). This will be within 7 days after 01/08/2024. JS Group will create your account on the [Santander Aspire webstore](#) so that you can purchase the MacBook Air. We encourage you to review JS Group’s privacy notice to understand how they’ll store and process your personal data when you use the webstore.

14. If successful, and once you've accepted the prize, you'll receive 2 emails from JS Group by 08/08/2024. One will include a link to the Santander Aspire webstore, including your log-in details. The other will confirm your award: 1 x Apple MacBook Air M2 in Space Grey.
15. If successful, and once you've accepted the prize, you'll be able to purchase an Apple MacBook Air 13-inch: Apple M2 chip with 8-core CPU and 8-core GPU, 256GB, 8GB in Space Grey, worth £999. JS Group will ring-fence your funds specifically to purchase your MacBook Air. You won't be able to purchase any other items with the allocated funds.
16. If successful, you'll have 12 months to purchase your MacBook Air. This will start from the date when you receive your log-in details from JS Group. The credit applied to your account will be removed after the 12-month period.
17. The winners' surname and county will be available on request after 25/07/2024 for 30 days, subject to the winners' consent. Please contact santander.universities@santander.co.uk to obtain these. The winners' information and winning entries (if applicable) must be provided to the Advertising Standards Authority on request in the event of a dispute.
