

# TERMS AND CONDITIONS FOR SANTANDER Open Academy | Open Scholarships

### I.- Objectives

The purpose of Santander <u>Open Academy</u> is to provide e-learning tools to help individuals obtain the training needed to access better professional opportunities. To qualify for services available on the Open Academy platform, individuals must complete a brief application by visiting <a href="https://www.santanderopenacademy.com/en/index.html">https://www.santanderopenacademy.com/en/index.html</a> (hereinafter, the "Website").

The purpose of Open Scholarships (offered by Santander Bank N.A. through Santander Open Academy) is to provide financial assistance through scholarships to aid in access to undergraduate studies for students.

### II.- Description of Santander Open Academy

Santander Open Academy is an e-learning platform offering courses, content and the opportunity to apply for scholarships at no cost. To apply to participate in one or more of one of Santander Open Academy's 1,000+ offerings, individuals are first required to register on the Website.

### III.- Candidate requirements and eligibility

The criteria for candidates are as follows:

Individuals must be 16 years of age to register for Santander Open Academy services. Registrants do not need to be a customer of Santander or its affiliates. Santander's Open Scholarships are only open and offered to entrants who, as of the entry date are legal residents of the 50 United States and the District of Columbia. Applicants who are eligible to apply for the Free Application for Federal Student Aid (FAFSA), including the associated citizenship or immigration status requirements, are also eligible to apply for this scholarship. Eligible individuals are at least 16 years of age or older; are enrolled or accepted as an undergraduate student as of August 1st, 2025 (college Freshmen, Sophomores, and Juniors); at an eligible, accredited two- or four- year U.S. brick-and-mortar or virtual/online college or university. Students must plan to be or be enrolled in a minimum of 12 credit hours per semester to qualify, or qualify as a full-time student at their respective university or college. Eligible grade levels include freshman, sophomores, juniors, and seniors. Eligibility based on year is further described below. Students pursuing graduate studies are not eligible.

- Rising college Seniors (Senior in the Fall of 2026) receive 5K over 1 year
- Rising Juniors (Junior in the Fall of 2026) receive 10K over 2 years
- Rising Sophomores (Sophomore in the Fall of 2026) receive 15K over 3 years
- Rising Freshmen (Freshmen in the Fall of 2026) receive 20K over 4 years



Directors, officers, employees of Santander Bank N.A., as well as individuals involved in the development, production or distribution of materials for Open Scholarships, and the immediate family members are not eligible to be awarded a scholarship.

### IV.- Website Registration and Application Process

New registrants must use an email address not currently registered with Santander Open Academy and then follow these steps:

- Go to the <u>registration page</u>.
- Answer the questions on the registration page. The password must have at least ten characters: including one upper-case letter, one lower-case letter and a number.
- Accept the general conditions and the privacy policy, then click "Register".
- Registrants will receive an email to verify their email address (if you can't see it in your inbox, please check your spam or junk messages folder).
- Open the email, confirm your address.

In the event of an error, open a <u>technical incident</u>, explaining your problem and attaching screenshots of the error.

Once a registrant has obtained their Santander Open Academy credentials, they will have access to the Open Scholarships application. After completing the application, they will be eligible to apply for a scholarship.

Each applicant is limited to one (1) entry per person/email throughout the application period. Applications must be complete, compliant, and submitted via Santander Open Academy within the time stated. Any application submitted via any other method will not be considered or accepted. Santander and Santander's fiscal agent, uAspire, are not responsible for technical, electronic, telephone, hardware, network, computer errors, or difficulties of any kind that result in an incomplete or illegible application.

### V.- Timing

The application will be open on August 1<sup>st</sup>, 2025, at 12:00 a.m. Eastern Standard Time and will close on December 1<sup>st</sup>, 2025, at 11:59 p.m. EST.

Scholarship funds will be determined in the Spring of 2026 and applied to the student's college/university starting in the Fall of 2026 for the 2026/2027 school year and over the course of their remaining undergraduate years.

## **VI.- Review of Candidates**



Scholarship awardees will be determined by a variety of factors including but not limited to academic achievements, demonstrated financial need, and extracurricular merit, etc. Demonstrated financial need will be based on applicant's need calculated from their Free Application for Federal Student Aid (FAFSA) application. Merit will be determined from transcript submission, and short answer portions of the scholarship application.

All scholarship awardees will be determined in partnership with community stakeholders. No less than 3 (permitted) individuals will review each final submission to ensure there is not a single point of decision that could allow favoritism/misappropriation to go undetected in the review and decision process.

#### **VII.- Notification**

Santander Bank N.A. and their fiscal agent will conduct a review of all applicants and will select up to 25 winners. Scholarship amounts will vary depending on awardee's year in college and anticipated time to graduation. Scholarship amounts will not exceed \$20,000 per awardee. Total scholarship amount will be divided amount the remaining years/semesters the student is enrolled. Financial need will be determined after the applicant has been selected in concert with the student's respective college or university. The determination of the amount will be decided in partnership with Santander's third party non-profit fiscal agent, uAspire. Scholarship award payments will be made directly to the university or college on behalf of the student. Scholarship award payments can be paused, should the student take leave from their studies.

Should any Open Scholarship award recipient become subject to expulsion or suspension from their college or university for any reason, brings any reputational scandal or disrepute to the sponsor, Santander, or their university or college, become ineligible by enrolling in fewer credits than deemed necessary to qualify, withdraws without proof from their respective institution, any remaining amount of the scholarship will be forfeited by the awardee.

The scholarship awardee has up to 6 years to utilize the scholarship funds. It is the responsibility of the awardee and the awardee's college or university to arrange for and execute all documentation required by Santander Bank N.A. and Santander's fiscal sponsor, uAspire.

### VIII. - Prizes/Approximate Retail Value

Santander Bank N.A. and their fiscal partner will award \$500,000 in Open Scholarships over the course of 2026. As previously stated, amounts will vary per scholarship awardee but can be up to \$20,000 per awardee.

Individuals who tamper with any portion of the Open Scholarship or Santander Open Academy, as determined by Santander or Santander's fiscal agent, uAspire, will be disqualified and no longer considered eligible for the scholarship. Any attempt to damage Santander Open Academy or disable, weaken, or alter the operation surrounding Open Scholarships and Santander Open Academy will result in Santander reserving the right to seek remedies and damages from any such person.

Scholarship Awards shall be dispersed following the criteria outlined in the selection process with no consideration given to existing relationship with Santander. Existing team members and their families are prohibited from receipt of awards, and the offering, promising, giving, or otherwise facilitating bribes, kickbacks, or other corrupt payments to influence the outcome of the scholarship selection process is strictly prohibited and may be fully prosecuted of the law.

### **XI.- Modification of Terms and Conditions**

Santander reserves in the exercise of their sole discretion the right to modify the Terms and Conditions of the Program, partially or totally at any time, with the purpose of preserving the objectives pursuant to Clause I informing about the modifications made to the candidates through the Website.

### XII.- Applicable Jurisdiction and Legislation

These terms and conditions are governed by the laws of the State of New York, and any dispute in relation to them will be resolved by the federal or state courts of New York County, New York.
