

Santander Universities iPad Pro prize draw

Terms & Conditions

Overview

Santander Universities are providing 10 undergraduates and post-graduates from all UK universities - the opportunity to win a brand-new Apple iPad Pro 4th Gen 11-inch Wi-Fi 128GB - Space Grey (worth £899). This is to support their university studies. Successful applicants will be able to buy their iPad Pro directly from the [Santander Aspire webstore](#) (owned and managed by a third party, JS Group).

Before entering the prize draw, read through these terms and conditions to make sure you meet all the criteria listed.

Terms & Conditions

These terms and conditions apply to the Santander Universities iPad Pro prize draw (referred to as the "prize draw"). By applying to the prize draw, applicants agree to be bound by the following:

1. The Grantor is Santander Universities UK (a division of Santander UK plc, 2 Triton Square, Regent's Place, London, NW1 3AN, United Kingdom).
2. iPad Pro is a trademark of Apple Inc. This promotion is not conducted in association with or endorsed by Apple Inc.
3. To enter, you'll need to meet the following eligibility criteria:
 - a. You must currently be studying an undergraduate or postgraduate degree (during the 2022/2023 academic year) at any UK university.
 - b. You must be a UK resident.
 - c. You must be able to provide a valid university student ID number.
 - d. You must confirm which UK university you attend.
4. You can enter the prize draw via the Santander Scholarship Platform any time from 09:00 (GMT) on 01/06/2023 until 23:00 (GMT) on 13/07/2023. Santander Universities reserves the right to close the prize draw early in exceptional circumstances (acting in its discretion).
5. Entries not submitted in accordance with these terms and conditions, or entries which are delayed, duplicated, incomplete, illegible, mislaid or lost through technical problems will be disqualified. No responsibility is accepted for such entries. Proof of submission online will not be accepted as proof of submission.
6. You can only enter the prize draw once.
7. It's your responsibility to ensure you read and understand the eligibility criteria and submit your entry appropriately, on time and following the entry requirements as shown on the Santander Scholarship Platform.
8. Santander Universities will select 10 winners at random using an online random-selection platform. If you want to find out more about this process, please contact santander.universities@santander.co.uk.
9. Once the 10 winners have been identified, Santander Universities will verify their student status.
 - a. As part of this verification process, Santander Universities will share the winners' names, email addresses and student ID numbers with their respective universities. This will take place prior to the results being announced, and will only apply if the winners attend a partner university (you can see a list of our partners [here](#)).
 - b. If the winners attend a non-partner university, Santander Universities will confirm the verification process directly with the winner(s) ahead of the results being announced. The respective winner(s) must then verify their eligibility by meeting the requirements outlined. Santander Universities will make 2 attempts to contact the winner(s) by email, with at least 24 hours separation between them, and a phone call if a valid phone number is provided. If after this, Santander Universities decides that it's not possible to get in touch with the winner(s), a new winner will be selected at random among the remaining applicants following the original process.

- c. Should the selected winners or respective partner universities not be able to verify the student status, a new winner will be selected at random to receive the iPad Pro instead.
10. If successful, you'll receive an email directly from the Santander Scholarship Platform which confirms you've been selected as a winner. When you receive this, you must accept the iPad Pro within 7 days of 24/07/2023. You can do this by clicking on the link in the email. Santander Universities may decide that it's not possible to get in touch with you if we email you twice with 24 hours in between, and call you on a valid phone number without a response, to confirm you accept the iPad Pro. If this happens, a new winner will be chosen from the remaining applicants following the original process.
11. If successful, and once you've accepted the iPad Pro, Santander Universities will share your details with JS Group (the third party managing the Santander Aspire webstore). JS Group will create your account on the [Santander Aspire webstore](#) so that you can purchase your Apple iPad Pro. We encourage you to review JS Group's privacy notice to understand how they'll store and process your personal data when you use the webstore.
12. If successful, you'll be able to purchase an Apple iPad Pro 4th Gen 11-inch Wi-Fi 128GB - Space Grey worth £899. JS Group will ring-fence your funds specifically to purchase your iPad Pro. You won't be able to purchase any other items with the allocated funds.
13. If successful, you'll have 12 months to purchase your iPad Pro. This will start from the date when you receive your log-in details from JS Group. The credit applied to your account will be removed after the 12-month period.
14. The winners' surname and county will be available on request after 24/07/2023 for 30 days. Please contact santander.universities@santander.co.uk to get these. The winners' information and winning entries (if applicable) must be provided to the Advertising Standards Authority on request in the event of a dispute.
15. If successful, you may be invited by Santander Universities or by your university (if you attend one of our partner universities) to provide a testimonial or case study. Please note, we will not publish a testimonial or case study without your permission.
16. Please be aware that, if you're identified as a winner and you attend a partner university, the Grantor will let your university know that you've won.
17. Please be aware that if requested by a partner university, if you've given consent, Santander Universities will let your university know that you've entered into the prize draw.

General terms
