## Terms & Conditions

### Overview

### Full terms and conditions

4 tickets (2 pairs) for UK residents. 2 tickets (1 pair) for residents of Germany, Argentina, Brazil, Colombia, Chile, Spain, USA, Mexico, Peru, Portugal or Uruguay.
  - Return transfers to Silverstone Circuit from hotel with private taxi on Thursday 2nd July and shuttle bus Friday 3rd-Sunday 5th July.

For residents in the UK, the the prize will also include:

- 4 nights' hotel accommodation (in Milton Keynes or surrounding area) from Thursday 2–Monday 6 July 2026 with breakfast included.

For residents outside of the UK, which includes Germany, Argentina, Brazil, Colombia, Chile, Spain, USA, Mexico, Portugal, Peru or Uruguay, the prize will also include:

- Return economy flights from an approved airport in the participant's home country to Heathrow airport in the UK. Please check Appendix A below for a list of approved city airport locations.
- Private transfers to/from Heathrow airport to the hotel.

- 5 nights' hotel accommodation (in Milton Keynes or surrounding area, UK) from Wednesday 1-Monday 6 July 2026 with breakfast included.

**The prize doesn't include:**

- Refreshments or meals at the FORMULA 1® PIRELLI BRITISH GRAND PRIX 2026.
- Transfers to/from the airport in the participants home country.
- Visa arrangements and processing.
- Fees related to flight document changes.
- Travel insurance.
