- 4. Create an account on Santander Open Academy (if you're not registered already)

Terms and conditions for the grant

- 1. All applications must be submitted via Santander Open Academy from 09:00 (GMT) 10/03/2025 until 23:00 (GMT) 15/05/2025.

Key Dates and Selection Process

1. Application process

 Applications are open from 09:00 (GMT) 10/03/2025 and will close at 23:00 (GMT) on 15/05/2025.

- You will receive confirmation of your application submission via an email from Santander Open Academy.

2. Selection process

Once applications have closed, each university will select 10 winners (from their own institution) at random. This will be done using an online random-selection platform.

3. Winners announced

 You will be told the outcome of your application on 03/06/2025 by 23:00 (GMT) via an email from Santander Open Academy.
