For UK residents:

For residents of Germany, Argentina, Brazil, Colombia, Chile, Spain, USA, Mexico, Peru, Poland, Portugal or Uruguay:

The programme will also include:

- Return economy flights from an approved airport in the participant's home country to Heathrow airport (United Kingdom). Please see Appendix A below for a list of approved city airport locations.
- Transfers to/from Heathrow airport to hotel
- 4-night accommodation in a hotel with breakfast included
