

Santander Student Tech Prize Draw (2025)

Terms & Conditions

Overview

At Santander, we want to connect as many students as possible with the resources they need to make the most of their studies. Santander are providing 50 students from all Further Education (FE) and Higher Education (HE) institutions in the UK - the opportunity to win 1 of 15 Apple iPad 11inch 128GB in silver (worth £349) or 1 pair of 35 Apple AirPods 4th Generation (worth £139) to support their studies. Successful applicants will be able to claim the iPad or AirPods (depending on which one they win) directly from the <u>Santander Aspire webstore</u> (owned and managed by JS Group). All prizes will be randomly allocated.

Terms & Conditions

- 3. To enter, you'll need to meet the following eligibility criteria:
 - You must be aged 18 or older and resident in the UK.
 - You must currently be registered and studying at any Further Education (FE) or Higher Education (HE) institution (during the 2024/2025 academic year) in the UK. You can also enter if you're doing a degree apprenticeship.
 - You must be able to provide a valid student ID number.
 - You must confirm which UK institution you attend.
 - You must register on the Santander Open Academy platform
- 4. You can enter the prize draw via the Santander Open Academy platform any time from 09:00 (GMT) on 02/06/2025 until 23:59 (GMT) on 17/07/2025. Santander reserves the right to close the prize draw early in exceptional circumstances (acting at its discretion).
- 5. Entries that do not meet these Terms and Conditions, or entries which are delayed, duplicated, incomplete, illegible, mislaid or lost through technical problems will be disqualified. No responsibility is accepted for such entries. Proof of submission online will not be accepted as proof of submission.

- 7. It is your responsibility to ensure you read and understand the eligibility criteria and submit your entry appropriately, on time and following the entry instructions/requirements indicated on Santander Open Academy.

- 9. If successful, you'll receive an email directly from Santander Universities confirming which prize (either an iPad or Airpods) you have won. In addition, you will also receive an email from the Santander Open Academy platform which confirms that you've been selected as a winner. Upon receiving this, you must accept the prize before 17:00 (GMT) on 25/07/2025. You can do this by clicking on the link in the email. You can also accept directly by logging into the Santander Open Academy platform and viewing 'My Learning'. If, after 2 email attempts with at least 24 hours separation between them and a phone call (if a valid phone number is provided), Santander decides that it is not possible to get in touch with you to confirm acceptance of the prize, a new winner will be selected among the remaining applicants following the original process.

Successful applicants will receive 2 emails from JS Group: one which will include a link to the Santander Aspire webstore, including log-in details, and another which will confirm your prize of either an Apple iPad or Apple AirPods (whichever one you have won). - 14. If you win 1 pair of the 35 AirPods, you'll be able to request a pair of Apple AirPods 4th Generation (with a value of £139). You'll have 12 months to collect your AirPods, starting from the date you receive your log-in details from JS Group. Your account will be credited with £139, and this can only be used to order the AirPods specified.
